

Life cycle stages included are illustrated in the Figure. Life cycle stages included are raw material extraction and processing, transport to the manufacturer and manufacturing of seating solution. Data for production year 2021 has been used. The production of plastic components is located in Sweden. Because the Balance Trainer is manually assembled, there are no environmental impact that can be separated, related to the assembly of the product (A3).
